**RAV Vast** is a steel tongue percussion drum with meditative, hypnotic and tranquil sound. All of the tones in one tuning are selected in such a way that it is impossible to play a wrong note. RAV Vast tongues are extremely sensitive and getting started takes minutes.

## **1. Correct use.**

- 1.1. The product is manufactured in accordance with technical requirements 962400-001-19984795-2017.
- 1.2. The product is designed to extract sound by hitting the tongues that are cut out on the surface.
- 1.3. The scale is specified on the wooden plug on the bottom.
- 1.4. Material: steel.
- 1.5. Form: two hemispheres of 550 mm in diameter.
- 1.6. All drums are of smooth matt greyish-blue, bright blue color sometimes with a violet shade and rough texture.

## **2. Operation Manual.**

- 2.1. It is not recommended for the product to be facing temperatures below +5 and above +50 degrees centigrade and relative humidity of more than 80%. Those extreme conditions may affect the tuning of the instrument. For long-term storage of the instrument, it is necessary that it is conditioned at room temperature. If the instrument was exposed to a high-temperature environment (a closed car in the sun, direct exposure to sunlight in hot weather), then it needs to be cooled down before using it.
- 2.2. The instrument has a wear-resistant protective rust-resistant coating and does not require any additional care. It is enough to wipe the instrument clean with a wetted rag or a wet wipe with no alcohol and then wipe it dry.



- 2.3. It is not recommended to apply any essential oils, organic oils, acetone, spirit, hydrocarbon solvents, alkaline products on the surface of the instrument. This may damage the coating.
- 2.4. Before storing the instrument for a long time, it is recommended to apply some vaseline oil or silicone on its surface and store it away from heating appliances. Eliminate the potential of heavy objects falling on the instrument.
- 2.5. The instrument is intended to be played by fingers or special mallets with soft heads. Playing with regular drumsticks or any other excessive physical impact may lead to the instrument going out of tune.
- 2.6. It is not recommended to interfere with the instrument's construction (e.g. re-painting, re-tuning with magnets, etc.) The company is not liable for the result of any actions of the kind.

### **3. Warranty.**

- 3.1. As long as the Manufacturer's operational recommendations are complied with, the maintenance period is 12 months.
- 3.2. If the instrument is stored before being used, then the warranty term is counted from the beginning of the usage of the instrument but makes not more than 2 years from the date of its production.
- 3.3. Within the warranty period, the Manufacturer conducts repair or replacement of the damaged instrument free of charge.

#### **The warranty becomes invalid in the following cases:**

- The above described operational recommendations breach;
- Mechanical damage that is not specified by the operational documents;
- Inappropriate use.
